

Visitation Guidelines

- No visitors with symptoms of illness such as sudden onset of fever, cough, headache, muscle and joint pain, sore throat and runny nose.
 - Patients with such symptoms are encouraged to wear a mask while in the facility.
- No visitors under the age of 16.
- Two visitors allowed on inpatient units during visiting hours:
 - Inpatient Units and Rehabilitation Units - 8 a.m. to 8 p.m.
- Two visitors allowed during outpatient, surgical and physician appointments.

*Exceptions to the above guidelines include:

Inpatient Behavioral Health	Two Designated Visitors 18 Years or Older	Visiting Hours 6 p.m. to 8 p.m.	Visitation outside of visiting hours allowed for discharge planning and education.
Patient in Labor or Postpartum	Two Visitors at a Time (Max 3 Designated Visitors) + Sibling Visits	Adult designated visitors (24/7) Sibling visitation 4 to 6 p.m. accompanied by only the designated adult visitors.	
Emergency Room (COVID+ or PUI Patients)	One Visitor 16 Years or Older	ER Visit	Must wear a mask.
CDU (COVID+ or PUI Patients)	One Visitor 16 Years or Older	CDU Visit	Must wear a mask.
Window Visit (COVID+ or PUI Patients)	Two Visitors	Visiting Hours 8 a.m. to 8 p.m.	Schedule visit with nursing unit leadership.
End of Life	Not Restricted	Unlimited (24/7)	If patient is in isolation, visitor must wear appropriate PPE.
Sudden Critical Event	Limit Two People at a Time - Immediate Family and Significant Others.	Unlimited (24/7)	Approval from nursing unit leadership needed for visitors under 16 years of age.
Expected or Unexpected Transfer to Another Medical Facility	Two Visitors	Within 60 Minutes Prior to Departure if Outside of Visiting Hours	Arranged by nursing unit leadership.
Endoscopy	One Visitor (due to space)		Two visitors may be approved in special circumstances.
Patient with disabilities that may include, but not be limited to; altered mental status, physical, intellectual or cognitive disability, communication barriers or behavioral concerns, who need assistance due to the specifics of their disability.	Two Visitors 16 Years or Older (One visitor will be allowed to stay at all times.) Non-COVID	Unlimited (24/7)	Request must be approved by nursing unit leadership. If COVID+ patient, only one designated visitor is allowed and must wear appropriate PPE.

During peak illness periods, masking may be required.
